Schmuckal stated that the Township was unable to purchase a property that was up for sale.

b. Staff Report/Updates

i. Parks Steward Report

Kehoe submitted the Parks Steward report in writing and indicated the men's bathroom at Silver Lake Recreation Area needs some work. A drone flyover was done over the Commons Natural Area and staff met with Township Engineer Jennifer Graham regarding details for upcoming parks priority projects, including River East Recreation Area.

Hannon stated that the Township Board adopted the Parks and Recreation Master Plan and Staff has submitted it to the Michigan Department of Natural Resources (DNR).

6. Old Business

a. PD 2023-23 – Grand Traverse Commons Natural Area Design Plan Implementation / Grants (6:10)

The Michigan Natural Resources Trust Fund (MNRTF) grant applications for 2023 have now opened on the DNR grants website, and Staff have begun filling out the required information. As part of the grant application process, there will need to be a public meeting to allow for discussion on the submission of the grant application. Commissioners decided that as part of their March 6 regular meeting, discussion would be heard on the MNRTF grant application.

Hannon stated that Staff and the Joint Planning Commission discussed the Sustain Our Great Lakes (SOGL) program from the National Fish and Wildlife Foundation (NFWF) as a potential resource for infrastructure improvements. Garfield Township and the City of Traverse City have been conducting an Infrastructure Assessment for the Commons area. The SOGL program may apply to this area and have potential benefits including improving stormwater management. There are many significant wetlands in the area, including on the Commons Natural Area site, which could be restored and may qualify for funding through this program.

Hannon added that another potential grant application may be the Trail Accelerator Grants offered through the International Mountain Bicycling Association (IMBA), which is anticipated to have a grant cycle opening in summer 2023. The mountain bike subcommittee may collect information pertaining to this grant.

Staff will prepare the information on the grant for the upcoming March 6 meeting. Grant assistance was discussed, and staff will investigate what work may be needed and come up with a cost for a potential grant writer. Other possible grant sources and programs include the MDNR Michigan Spark Grant and Rotary Charities.

Additional grant funding may be available for invasive species control (autumn olive, etc.), piggy backing the Spring Planting through Conservation Resource Allaince.

Subject:	Grand Traverse Commons Natural Area Design Plan – Grants Update				

BACKGROUND:

The Township Board adopted the Garfield Township 2023-2027 Parks and Recreation Master Plan, including the Grand Traverse Commons Natural Area Design Plan, at their meeting on January 10, 2023. The Plan was approved by the Michigan Department of Natural Resources (MDNR) in February 2023 and allows the Township to maintain eligibility for MDNR grant programs including the Michigan Natural Resources Trust Fund (MNRTF).

The Township Board supports applying for an MNRTF grant and will hold a public meeting at their regular meeting on March 14, 2023 to receive input about the application. The application is due to MDNR by April 1, 2023.

STAFF COMMENT:

Staff offers the following comments on grant programs:

- The MNRTF grant application is for a portion of the "Conservation Recreation" Trail in the northern portion of the Commons Natural Area property. This trail will be designed as a universally accessible (UA) trail and form an approximately 1.4-mile loop.
- Part of the grant application process is an Accessibility Review including input from people with disabilities, disability advocacy groups, and other organizations which serve people with disabilities. Staff met with two representatives from Cordia at Grand Traverse Commons, a senior living organization, and had a discussion with a representative from Disability Network Northern Michigan. Some key points raised include:
 - Different trail materials present different advantages and disadvantages for people with disabilities.
 For example, specific challenges include cracking in pavement and slick conditions on boardwalks.
 The Township will likely need to include some boardwalk near wetlands; otherwise, the trail will be primarily crushed gravel.
 - As a regional example, Timbers Recreation Area in Long Lake Township received an MNTRF grant for a UA trail which included boardwalk and crushed gravel sections. This trail opened in 2019.
 - Disability Network Northern Michigan will do an accessibility review of the complete application, and indicated the minimum width of the trail should be at least 6 feet, ideally 8 feet, and 10 feet for sections intended for both hiking and biking.
- Staff have drafted a letter for outreach to area stakeholders, including those who provided input during the planning process, and a draft letter of support (see attached documents). Several stakeholders have already indicated a willingness to provide a letter of support for this grant application.
- Staff and the Township Engineer have discussed drawings and details required for inclusion with the MNRTF application and are working on finalizing these details.
- Staff and the Township Engineer are working on details for an application for the Oleson Foundation grant program, with the focus on artesian well improvements and wetlands management.

Subject:	Mountain Bike Subcommittee Update				

OVERVIEW:

In January 2023, the Parks and Recreation Commission agreed to create a subcommittee focused on issues related to the mountain bike trail area at the Grand Traverse Commons Natural Area. The subcommittee's input will be useful in guiding future projects here to implement the Commons Natural Area Design Plan.

The subcommittee met for the first time on February 22, 2023 at Township Hall and included representatives from Copper Ridge Riders Association (CRRA), Northern Michigan Mountain Bike Association (NMMBA), and others. Members of the subcommittee discussed the following items:

- Existing Trails CRRA members have been conducting an inventory and gathering photos to document the status of the existing mountain bike trails. Subcommittee members will be meeting with Township Staff on the property to assess specific areas of concern regarding erosion, trail crossings, signage needs, and safety, and to determine appropriate action which may potentially include closing off some trail sections.
- Fundraising The subcommittee discussed strategies for fundraising and generated an initial list of people to ask for donations or potentially help with fundraising. They also discussed the need for a project website and branding to help promote the project to potential donors. Staff will also continue seeking grant programs to which the Township could apply including the Trail Accelerator Grants through the International Mountain Bicycling Association (IMBA), which is anticipated to have a grant cycle opening in summer 2023.

Other topics of discussion included design considerations for potential future trails, and how to handle maintenance of any future trails. The subcommittee scheduled their next meeting for March 15, 2023.

STAFF COMMENT:

During the discussion on fundraising, some wondered if forming a 501(c)(3) nonprofit entity would be appropriate for any fundraising activities, with Preserve Hickory cited as an example. Staff followed up with a representative of Preserve Hickory to discuss how collaboration works between Preserve Hickory as a 501.c.3 and the City of Traverse City as a municipal entity.

The 501(c)(3) model was cited as beneficial because it was seen as a more appropriate recipient of donor money and provided tax benefits to donors. Also, some grants allow 501(c)(3) organizations to apply but not municipal entities. Staff intends to bring this topic to the next subcommittee meeting and will continue to research if this approach is the best course of action for the Commons Natural Area.
