As Derek Weichlein from our office is out on maternity leave, I am following up on the status of this project (two sites) as our contractor has received the strain poles to complete their work.

As indicated in the preceding email, the GTCRC believes we have met all the necessary requirements as follows:

- S. Airport/Veterans: Garfield Township no longer desires to have the lights at the S. Airport at Veterans intersection re-installed – *Can the Township Supervisor, Mr. Chuck Korn reply to this email to grant the removal of these streetlights? If not, what is the number and who is he to talk to give this approval?*
- S. Airport/Garfield: Address permit is being re-sent for your use.

Additionally, both intersection inspections and Electrical Certificates of Acceptance are included for your use.

As our contractor, J. Ranck, is planning on to complete their work starting the week after Thanksgiving, November 27th, please respond to this email that power to these meters will be accomplished by this timeframe.
