Spence summarized the non-motorized analysis recently completed by the MSU urban planning student group. Their goal was to help develop Garfield Township's non-motorized transportation plan and to create an evidence-based process for future planning. The three highest priority corridors identified for non-motorized improvements in the area were the Mall Trail to Miller Creek, LaFranier Road, and South Airport Road from Barlow to the Boardman Lake Loop.

6. Old Business

 a. PD 2022-46 – Grand Traverse Commons Natural Area Design Plan – Review of First Public Open House and Overview of Project Net Steps (6:10)

On Wednesday May 11, the Township and Environmental Consulting & Technology, Inc. (ECT) hosted an open house at the Cathedral Barn seeking public feedback on the future design for the Commons Natural Area. Materials displayed at the open house included an overview of existing conditions and two conceptual designs: one showing primarily separated trails and another showing mainly shared-use trails. People were encouraged to leave comments on these conceptual designs and give their input. Members of the public commented on the trails, outdoor education areas, wayfinding, and highlighting natural features. An online survey was also made available and the public commented on many of the same items. The next open house will focus on design scenarios in more detail and options for the specific site elements. Hannon gave an overview of some key discussion points including potential options at the trailheads, and Commissioners discussed the site.

7. New Business

a. Discussion – 2023 Priority Parks Projects (6:47)

Hannon asked Commissioners to provide ideas for priorities projects for 2023. Commissioners talked about focusing on maintenance at Silver Lake Recreation Area as well as a second dog park there. They also discussed possible projects at Commons Natural Area and River East. Chair DeGood commented on obtaining Rotary funding for some park projects and completing a DNR Trust Fund application. Fundraising for projects at the Commons was also suggested, and the Grand Traverse Regional Land Conservancy was suggested as another funding source.

Repairs made to boards on boardwalk that have come loose.

Miller Creek

As mentioned earlier, brush hogging/mowing has been conducted by the township now.

Resolved issue of contractor for nearby church dumping cement over the hill at Miller Creek. All material has been removed by the contractor.

Monitoring for encampments and graffiti.

Several downed trees removed this spring/summer.

Kid's Creek

BACKGROUND AND UPDATE:

This report provides an update on the planning process for the Grand Traverse Commons Natural Area.

Next Public Engagement Event – Open House at Kirkbride Hall

The next public engagement event will be Wednesday August 10 from 3-6 PM at Kirkbride Hall and hosted by the Township and Environmental Consulting & Technology, Inc. (ECT). At the first public open house in May, the Township and ECT sought public feedback on some general concepts for the site. There was general support for trails separated by use type, especially to keep bikes away from other users. Some of the other preferences included highlighting natural features and historic elements, improving wayfinding, and incorporating areas for outdoor education.

The next open house will seek public feedback on a more refined site design concept. This design shows a more separated trail network between hiking and biking, with some defined areas where these two activities would overlap. Biking is generally more focused on the western ("State 40") and central parts of the site, with hiking throughout the entire site. Some existing trails would be closed or potentially rerouted in this scenario, especially where trails may impact sensitive natural features.

This concept also shows designs for three trailheads: Copper Ridge, Red Drive, and North Long Lake Road. Staff and ECT have had discussions with several stakeholders about trailheads and access to the Commons Natural Area site, including property owners of sites with existing trailheads. In talking with stakeholders, it appears there would be limited opportunities to expand trailhead access at Historic Barns Park, Yellow Drive, and Gray Drive. The Copper Ridge trailhead would be moved from its current location under this concept and enable direct access from Park Forest Drive. The Red Drive trailhead would stay in the same location and include an updated design. The North Long Lake Road trailhead is proposed to be moved to the edge of the site near Munson across from Oleson's grocery store and would feature a gravel parking area and restored wetland.

Conceptual drawings of the trail system and trailheads are attached to this report, and Commissioners are encouraged to provide feedback. These concepts are intended to be used in the public engagement event on August 10.

NEXT STEPS:




Concept Zones Version 4























HUB 1 & 2 CONCEPT





BACKGROUND:

In October 2021, the Parks and Recreation Commission recommended to the Township Board a list of the priority parks projects for 2022. These projects formed the basis of the capital outlay portion of the parks budget which was eventually adopted as a part of the overall 2022 Township budget. The following table indicates the status of these projects:

Silver Lake	Tennis court resurfacing	Project anticipated to start mid-August

2023 PRIORITY PROJECTS:

Commissioners conducted a preliminary discussion on 2023 priority projects at the June 6, 2022 meeting. Some ideas for priorities included added dog park space at Silver Lake Recreation Area, the next phase of River East Recreation Area, and projects to implement the Commons Natural Area Design Plan. Staff has compiled a list of potential 2023 priority projects including the following:

Park	Project	Anticipated Cost
River East	Phase #3 – bathrooms, trails, and sidewalk	\$348,000
GT Commons	Commons Natural Area Design Plan implementation	\$100,000
TOTAL		\$448,000

Staff anticipates two major projects for 2023: the next phase of improvements for River East Recreation Area and beginning implementation of the Commons Natural Area Design Plan. The next phase of River East Recreation Area improvements includes bathrooms, trails, and sidewalk. The conceptual plan of this park was prepared by the Township Engineer and is attached to this report.

The Commons Natural Area Design Plan will be completed by fall of 2022. The Design Plan anticipates projects to take place over the next several years such as trailhead enhancements, landscaping, restoration of natural areas, and redesigned trails. Estimated costs for projects will be included with the final Design Plan. The Township will also pursue outside funding through grants (e.g., Michigan Natural Resources Trust Fund, Rotary Charities, etc.), and so the Township contribution to some of these projects may be via a local match to a grant.

These two projects both have large scopes of work, and thus are recommended as highest priority projects for 2023. Commissioners may identify other projects for 2023 or future projects beyond 2023 to keep on the radar, allowing time to investigate the costs and feasibility of these projects.

ACTION REQUESTED:

The purpose of placing this item on the agenda is for the Parks and Recreation Commission to discuss the list of 2023 priority parks projects and if any changes should be made to this proposed list, and to make a recommendation to the Township Board as they begin discussion on the 2023 overall Township budget. Following the discussion, if the Commissioners are comfortable with the list of proposed priority projects, then the following motion is suggested:

MOTION TO RECOMMEND to the Township Board the list of priority Parks and Recreation projects for 2023.
