Subject: Concert venue in the Cherryland Mall?

Greetings!

I saw the Ticker on September 12th and read about the proposed Nightclub/Concert venue at Cherryland Mall and wanted to go on record that I think that would be a very poor fit for our neighborhood. I really appreciate you and the planning commission tabling this for further consideration. I would be very concerned about noise, traffic and parking that this business would bring and ask you to take into consideration the following issues in regards to this.

Noise; The backside entrance of the Cherryland Mall, where the venue's entrance is proposed, is approx. 600ft from our back porches on Woodward Ave and about the same distance to the backyards of the Forest Lane Dr neighborhood. I truly believe, with some years myself in the concert/event industry, that no amount of internal sound abatement would keep the bass from a 2000 person concert from resonating through the houses in both neighbors. Back when Streeters was open all the way across Garfield Ave we could hear & feel the bass from their larger events, imagine what that'll be like only 600ft away from your house.

Traffic; I would also be very concerned about the activity that 2000 people would create in the parking lot. Even when there are smaller gatherings of people in that parking lot on a summer night we can hear people clear as day when our windows are open. You might also be aware that the back parking lot of the Cherryland Mall became an attractive nuisance this summer for drag racing and car meet ups for people doing donuts, burnouts and speeding, we had to work with the Sheriff's dept on numerous occasions to put a clamp down on this activity and while the Sheriff's Dept. were super responsive, I can easily picture this kind of behavior returning as patrons were leaving a concert or nightclub, alcohol doesn't make for the best behavior or neighbors.

Parking, even though staff feels there is adequate parking, I ask you to consider that if there was a sold out event happening at this venue while the other Cherryland businesses are operating and add in the parking needed for future businesses such as a 24/7 Golf etc the parking will fill quickly. Our neighborhood would become the defacto default overflow parking for the mall, this has happened in the past when there was a presidential political rally that used the Cherryland Mall as it's overflow parking and when that was full our whole street filled with cars everywhere, some places they double parked and even parked in the open lot across the street from our house. The Woodward Ave neighborhood already has very very limited parking for those of us who live there and isn't equipped to be an overflow parking area for a large nightclub/concert venue.

Once again we appreciate all you do and appreciate you taking a pause to further look into this. A 2000 person nightclub/concert venue is not a "harmonious" and "compatible" use of a property that is only 600ft from the back porches of two different neighborhoods and no amount of sound abatement or 'buffering the rear area from neighbors with a new wall and landscaping' will prevent this from becoming a nuisance and potentially even driving down housing values in two very quiet neighborhoods that back up to the venue. In the past I believe the commission had passed on a proposed storage facility for potential neighborhood disruptions due to late traffic and noise and I believe the township should definitely pass on this proposal for the same reasons. As the saying goes 'just because you can do something doesn't mean you should'



Good morning, John and Steve,

I am the resident and owner of 1701 Woodward Avenue, Traverse City, MI. I am writing because I have recently become aware that there are plans being voted on regarding potential occupants of the old Sears Building at the Cherryland Center. It was shared with me that the township is considering allowing a Night Club to be allowed at that site.

I have lived at my address for 15 years now and have seen and heard many things happening in the parking lot just beyond our backyards. Oftentimes, township noise ordinances are not observed by people going through that space as it is not monitored, at least not well enough, to prevent disruptions to neighborhood residents between 10pm -6am.

Any business that operates between 8am - 10pm would potentially not present a conflict for the adjoining residential community. A night club, however, most likely is not intending to close each night at 10pm. People coming and going in that parking lot after 10pm into 11pm, 12pm, 1am or 2am would most assuredly cause noises, whether amped up mufflers or those in disrepair, people squealing tires (which happens more often than you'd think), or, in this case, people coming out inebriated and unaware of how much their voices are carrying, whether it be by singing, yelling back and forth across the parking lot or fighting/screaming at eachother, that invariably comes with people attending night clubs (and the consumption of alcohol).

Unfortunately, there are other factors that will possibly increase as well. We have had many loitering vehicles in the old Sears parking lot. They are parked literally 50 yards or less from the most southern unit on our property. These vehicles and their occupants are sometimes there for weeks, and in other cases, it appears they are there during the day 'doing business' out of their cars.

The residents of the Woodward avenue communities are not a high socio-economic class. They are regular working folk who peacefully coexist and are trying to have a place to escape to at the end of the day where they can safely and peacefully enjoy their friends and loved ones, and raise their families. Having and maintaining a peaceful community that allows for that in a more densely populated neighborhood is difficult enough in itself (and the people currently living in this neighborhood who are already pulling that off should be applauded. I urge you to please help set them up for success.). Adding a nightclub within almost 100 yards of these families would definitely have an impact and influence, and I unfortunately have to say that it, in reality, would not be a positive one.

I am a fan of night clubs, I very much enjoy going out, socializing, dancing and the like. However, I do not enjoy that it could be at the expense of the well being of a neighborhood community.

Ultimately, I would like you to find a better fit for a tennant at the Cherryland Center, a business that will

help promote community and preserve positive influences to the nearby young families. If I was not required to be out of town for work on October 9th, I would most definitely be there to share these concerns and others and strongly ask you to vote No to the proposed Nightclub at Cherryland Center.

I, along with the other owners of Kensington Park East, greatly appreciate your sincere consideration of our concerns. Thank you for your time.

Nightclubs do not belong in residential areas!!

I live directly behind the old Sears building and I understand that there is interest in turning this into a Night Club. I am very concerned because I do **NOT** want this night club.

I am a homeowner; I fear the Night Club would bring down the value of my home due to the increase in noise this will make in the middle of the night and there will most certainly be an increase in crime and violence due to increase in substance abuse. We already hear too many police sirens and ambulance sirens now.

Along with an increase in crime & violence, the increase in noise will be too much to bear at all hours of the night. It is very loud already with the increase in air traffic. Now the airport is looking to expand its airport with the proposed \$120 million dollar expansion. This will increase the number of flights in and out of the airport. In 2023 there was a marked increase in travelers to 700,000 people!
